

**Resolution 2021-05-000**  
**Board of Trustees Stokes Township, Logan County, Ohio**

The Board of Trustees of Stokes Township, Logan County, Ohio met in regular session on Tuesday, May 11, 2021 at the Stokes Township building at 8:00 PM with Mr. Tim Hart, Mr. Steve Terrill and Mr. Orvil Wickersham present.

Mr. Steve Terrill moved the adoption of the following resolution and moved its passage.

**RESOLUTION FOR PARKING VEHICLES  
ON TOWNSHIP ROADS**

*WHEREAS*, the Ohio Revised Code, Section 505.17(A), has granted upon the Township, the authority to make regulations and orders as are necessary to address vehicle parking in the Township. This authorization includes, among other powers, the power to regulate parking on established roadways proximate to buildings on private property as necessary to provide access to the property by public safety vehicles and equipment.

*WHEREAS*, the Township wishes to exercise its authority to regulate parking on Township roads, pursuant to Ohio Revised Code section 505.17.

*NOW THEREFORE BE IT RESOLVED*, by the Board of Stokes Township Trustees, Logan County, Ohio hereby permit the parking of vehicles, including recreational vehicles, on all residential roads that are owned by the Township, subject to the following limitations:

1. Parking is not permitted within ten feet of a fire hydrant.
2. Parking is not permitted on an undeveloped road that is not being maintained by the Township.
3. Parking is not permitted on a dead-end street.
4. Parking is not permitted in front of any public or private driveway.
5. Parking is not permitted in front of any mailbox.
6. Parking is not permitted alongside or opposite street excavation or obstruction when such standing or parking would obstruct traffic.
7. Every vehicle stopped or parked on a two-way street or roadway where there are adjacent curbs shall be stopped or parked with the right-hand wheels of such vehicle parallel to and within twelve inches of the righthand curb.
8. Parking is not permitted on any developed or undeveloped roadway where someone is overnight camping or living in a vehicle.
9. There is no parking on any township road between the hours of 2:00 am and 6:00 am daily.


Mr. Orvil Wickersham seconded the motion.
